OFFICE MEMORANDUM

Subject: Submission of claims for Quarter-3 of FY 2021-22 under Special Credit Linked Capital Subsidy Scheme (SCLCSS) of National SC-ST hub through Online Application and Tracking System of MIS and acceptance of applications - regarding.

The undersigned is directed to state that **Special Credit Linked Capital Subsidy Scheme (SCLCSS)** has been introduced under **National SC-ST Hub (NSSH)** with the objective to promote new enterprises and support the existing enterprises in their capacity development for enhanced participation in the public procurement. It is being implemented as per the prevalent guidelines of Credit Linked Capital Subsidy component under CLCS- TU Scheme.

2. As per the revised NSSH guidelines issued vide OM No. No. K-02/4/2021-SME dated 15.11.2021, **service sector has been included under SCLCSS component** (w.e.f. date of issuance of NSSH guidelines i.e. 15.11.2022). **Subsidy of 25%** is to be provided to the eligible SC-ST MSEs of **manufacturing as well as service sector** from National SC-ST Hub for procurement of plant & machinery / equipment through institutional credit (maximum subsidy -Rs.25 Lacs).

3. The SCLCSS/ CLCSS MIS portal (<https://clcss.dcmsme.gov.in>) is being modified for acceptance of SCLCSS claim applications in respect of Service Sector SC/ST MSEs. In the meanwhile, **SCLCSS claims for Quarter-3 of FY 2021-22 in respect of SC/ST MSEs of manufacturing sector are invited** as per the timelines attached herewith (Annexure). The timelines for SCLCSS claims of service sector SC/ST MSEs shall be issued separately.

4. All the concerned nodal banks / agencies are hereby notified that **fresh subsidy claims under SCLCSS for Quarter 3 of FY 2021-22** i.e. reference date from 1st October, 2021 to 31st December, 2021 are to be submitted through existing Online Application and Tracking System of O/o DC-MSME i.e. <https://clcss.dcmsme.gov.in>. **A window in the existing system (MIS) shall be operationalized during the stated period (refer annexure) for the submission of applications under SCLCSS. It is informed that Login ID and Password will remain the same.** The claims under SCLCSS will be settled by NSIC with budgetary support available under NSSH. The timelines for submission of claims through above portal are mentioned in the Annexure attached.
